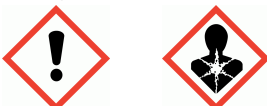

**SECTION 4: First aid measures****4.1. Description of first aid measures**

<b>Inhalation</b>	Move affected person to fresh air at once. Get medical attention if any discomfort continues.
